Type: This product is an OTC Commo Accumulator

Objective: You aim at buying an agreed quantity of the Reference underlying below the current market price at a predefined value (called the Buying Price). This will correspond to the Daily Number of Underlying Units if the Reference Underlying closes at or above the Buying Price and to the Daily Number of Underlying Units multiplied by the Buying Multiplier if the Reference Underlying closes below the Buying Price. This quantity is delivered on the Settlement Date of each Observation Period. During any Observation Period, if the Reference underlying closes above the Knock-Out Barrier, the product is early terminated and you receive the quantity of the Reference underlying bought during this period on the Knock-Out Settlement Date.

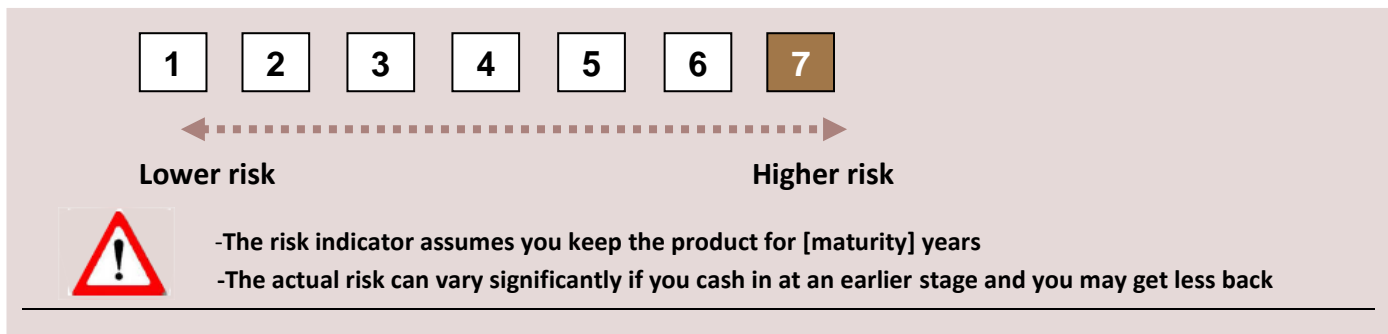
