**Type:** This product is an OTC FX TARF Accumulator

**Objective:** You aim at buying an agreed amount of Currency 1 against the payment of Currency 2 below the current market price at a predefined value (called the Buying Price). At the end of each Observation Period, you will receive the sum of 2 amounts in Currency 1: the Daily Amount per Observation Date during this period when the Reference underlying fixes above the Reference Price, and the Daily Amount multiplied by the Buying Multiplier per Observation Date during this period when the Reference underlying fixes at or below the Reference Price. In exchange of this amount, you will pay the equivalent amount in Currency 2 using a conversion rate corresponding to the Reference Price. During any Observation Period, if the Profit Figures accumulated are equal or superior the Target Level, the product is early terminated and you receive the sum of the 2 amounts (accrued) in Currency 1 in exchange of its equivalent amount in Currency 2 as defined above.

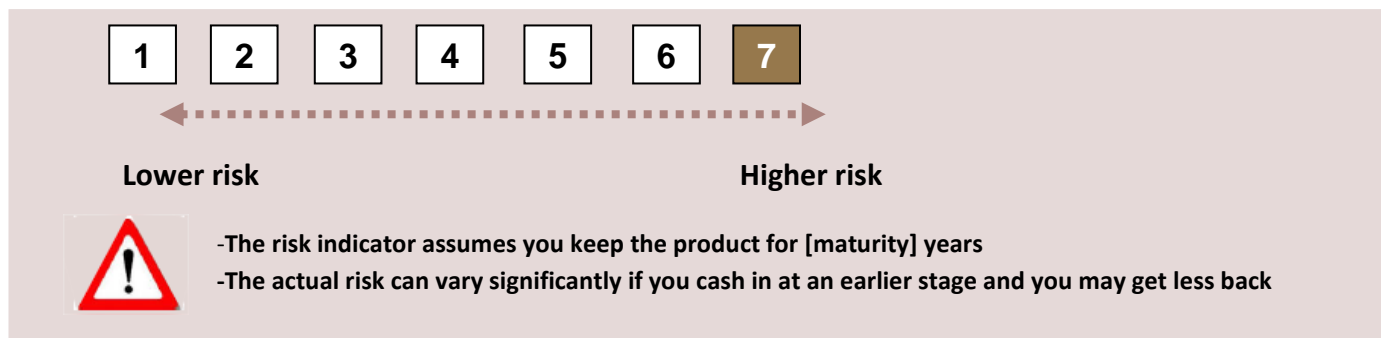
