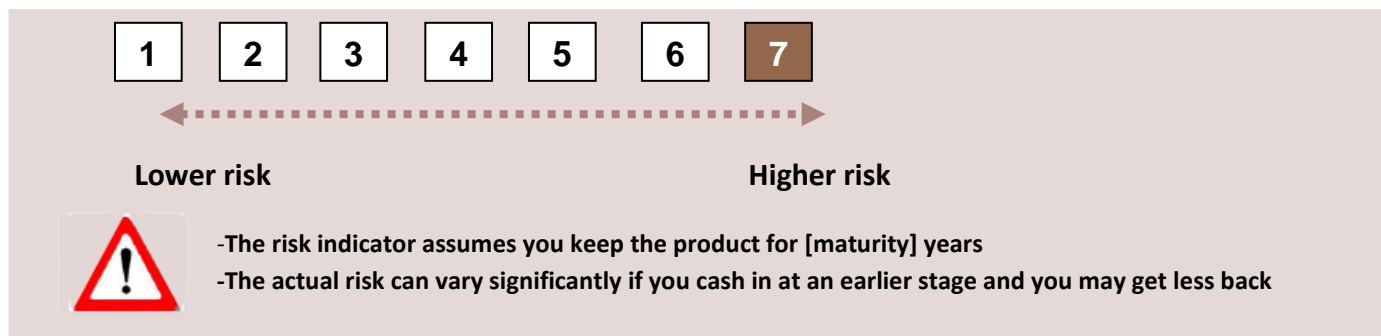

Summary Risk indicator
